VIDEO RECORDING INSTRUCTIONS

Select a text and use your smart phone or tablet to record yourself reading the text. A list of readings accepted for the online video installation is on the Blood Lines Participation page.

You may choose any name from the following list, whether it has already been read or not. We will showcase multiple readings in the online installation.

Choose a recording setting and check your lighting and sound. Please set up the device to record in landscape mode.

Look into the camera and speak clearly and slowly. You do not need to memorize the text. Though you may read the text as is, we encourage you to put it into your own words. Each reading should be between 20–30 seconds long.

When you are satisfied with your recording, please edit the beginning and end of the video. Once you have completed the form you will receive an email with the upload link.
